Section I: Court Cases (60 Points)

1. Research the 15 court cases listed below and answer the following for each case listed in complete sentences:

1) The "Constitutional Question" brought up by the case. What amendment and/or clause is discussed?

2) Background information. What is the case about?

3) Opinion of the court and long term results. What impact did the precedent have?

The journal needs to be **handwritten**. Students will use these cases throughout the semester and need to be familiar with some of the landmark decisions and precedents set by the Supreme Court. Information can be found on several reliable websites. I recommend <u>www.oyez.org</u>. Do not rely exclusively on Wikipedia! Also, make sure **the cases are numbered** and are in the front section of your spiral notebook.

2. (Purpose) Find one sentence or statement in the document that you believe summarizes or helps explain the major purpose of the document. Once you find it, write out the statement/sentence in its entirety and provide an explanation in 2-3 sentences as to why you chose this statement/sentence.

3. (Connection) Explain how you think this document will relate to AP Government 2-4 sentences

4. (Application) Give me a bumper sticker saying that helps to explain and remember the major purpose of this document. Include this at the end of your analysis with a brief explanation. Feel free to be creative and have fun this section!
